ORDER:

Government of Andhra Pradesh is implementing the various social and sectoral programmes for the development of the state and one of the promises under the category of 'Super Six' for development, welfare and social justice is creation of 20 lakhs employment. With the commitment to create substantial employment opportunities by focusing on key sectors and leveraging the state's strengths, the Government is bringing out various Policy and Schematic Interventions to generate jobs for about 20 lakh individuals over the next five years.

2. In its journey to achieve creation of 20 lakhs employment by 2029, Government hereby constitute a Group of Ministers (GoM) to suggest measures and mid-term corrections and to institutionalize a suitable monitoring mechanism with the following members.

B. Terms of Reference

- a. To suggest various measures to achieve the objective of providing employment by bringing best policies and best interventions and across various line Departments.

- b. To review periodically and to suggest necessary corrective measures/ remedies
- c. To suggest suitable institutional mechanism to monitor & regularly update the employment provided in public and private sectors.

C. Other Information

- a. All the line Departments, besides implementing the sector-specific schematic and non-schematic interventions towards employment generation, have to nominate a senior official (not below the level of HoD or JD or JS level officer of the Department) to participate and contribute in the meetings of GoM and to update the details on regular basis.
 - b. The Skill Development and Training Department and Director of Industries will provide the necessary secretarial assistance and other support to the Committee.
3. The Skill Development and Training Department and Director of Industries shall take necessary further action in the matter, accordingly.
